

Critical criteria in Management's evaluation process will include the Service Provider's ability to share data and jointly develop scope of service which meets or exceeds our mutual needs.

Scope of Work

Complete checking and semi comprehensive maintenance Every Three Months floor by floor the whole system as per the following details (4 PPM services per year) :

- Checking & servicing hopper door units, indicators & control panel
- Checking & servicing chute cleaning system.
- Checking and adjusting the door balancing system.
- Provide emergency on call services.
- Submit a detailed report after each visit.
- Full Garbage Hopper Doors & Chute Duct inside cleaning and disinfecting floor by floor. Cleaning Chemicals will be used to clean the internal surface of the chute duct. Two (2) times cleaning in a year (Every Six months One-time manual deep cleaning)

- Hopper Door Shock Absorber or Gas Spring
- Hopper Door Magnetic Locks.
- Hopper Door Latches.
- Hopper Door Indicators
- Cleaning sprinklers or Devices
- Timers & Limit Switches.

- Disinfect Chemical Unit
- Fire cut off door-Including Fusible
- Main Garbage Trolleys Wheels
- Main Garbage Trolleys Door Handles
- All Electrical Works Related Accessories to control panel.
